DEED OF DISCHARGE, RELEASE & INDEMNITY

1.1 THE PARTICIPANT CONVENANTS AND AGREES WITH THE FOLLOWING RULES, TERMS AND CONDITIONS:

The participant agrees to abide by the rules of Laser Scape at all times when present at the Laser Scape Venue.

- a) No projectiles are to be thrown, kicked or otherwise made airborne by participants.
- b) No participant shall engage in –
 - Skylarking or reckless behavior or Foolish behavior: or
 - Any other behavior likely to cause injury to Themselves or Other participants: or Employees or agents of Laser Scape: or
 - Any other behavior which Laser Scape deems in its absolute discretion to be unacceptable.
- c) Laser Scape may require any participant engaging in unacceptable behavior to leave the Laser Tag Venue.
- d) Each participant must remain within the designated boundaries of the Laser tag Venue at all times.
- e) Each participant will be required to wear long trousers and sturdy enclosed shoes.
- f) All participants must follow the directives of Laser Scape at all times.
- g) Any participant injured, or observing another participant to be injured, shall immediately notify Laser Scape staff of the incident.
- h) NO SMOKING or ALCOHOL within the Laser Scape Venue.

1.2 RELEASE AND DISCHARGE

The Participant releases, discharges, waives and forever holds harmless Laser Scape from All Claims for Any Loss sustained by the Participant whether caused by Laser Scape's negligent act or willful act or omission, breach of contract, breach of statutory duty or otherwise in connection with Laser Scape.

1.3 INDEMNITY

The Participant indemnifies Laser Scape against All Claims for Any Loss sustained by the Participant whether caused by Laser Scape's negligent act or willful act or omission, breach of contract, breach of statutory duty or otherwise in connection with Laser tag.

1.4 WARRANTY AS TO AGE

By personally executing this Deed, the Participant warrants that or she is at least of eighteen (18) years of age. Where this Deed is executed by a parent, guardian, or other person for and on behalf of the Participant, the person so executing warrants that he or she has authority to do so and that such parent, guardian or other person agrees to indemnify Laser Scape in terms of the indemnity contained in clause 1.3 hereof.

1.5 BAR TO ACTION

The Participant agrees that this deed may be pleaded as a bar to any action, suit or proceedings taken at any time by the Participant against Laser Scape arising out of or as a consequence of Laser tag or any incidental activities.

1.6 CONFIDENTIALITY

The Participant must keep the terms of this Deed strictly confidential and no disclosure or the terms of this Deed is to be made by the Participant other than for the purpose of obtaining legal advice.

1.7 BINDING ON SUCCESSORS

This deed binds the heirs, administrators, executors, personal representatives, dependants (if any) and successors of the Participant and endures for the benefit of Laser Scape and its successors and assigns.

1.8 DEFINITIONS

In this Deed unless inconsistent with context or subject matter:

"All Claims" means all claims, actions, suits, demands, damages, interest and costs arising out of or as a consequence of the participants participation in Laser tag, including any incidental activity;

"Any Loss" means any loss, damage or injury to person (including the Participant) or property including but not limited to:-

- a) Any damage or injury occasioned to a participant, howsoever, by:-
 - i. Any logs, trees and branches or any part thereof;
 - ii. Any rocks, falling boulders or stones;
 - iii. Any rivers, creeks, streams or any other body of water existing at a Laser tag Venue;
 - iv. Any snakes, spiders or any other wildlife whatsoever;
 - v. Other participants;
 - vi. Any equipment supplied to the Participant by Laser Scape in connection with Laser tag;
 - vii. Or otherwise arising out of the Participant's involvement in Laser tag.
- b) Any damage or injury occasioned to a Participant as a result of a Participant:-
 - i. Slipping on rocks, boulders, logs, trees, land or any other substance; and/or
 - ii. Falling over; and/or
 - iii. Colliding with another participant whether caused by negligence, or accident, or another participant, or flora or fauna, or however otherwise caused.

"Laser tag" means the outdoor live action role-play combat game run by Laser Scape

"Laser Scape Venue" means the location at which Laser tag/ Laser Scape is being convened.

"Participant" means their full name, address, and telephone number as per section one of this form.

"Laser Scape" means a business of Laser scape ABN 19833113784 and its agencies, suppliers, distributors, servant's employees, agents, representatives, directors, and officers.
